- . Open to ALL Malaysian students

- . Opening date for 2024 Applications is Thursday, 1st August 2024 for STPM students who wish to apply to join vocational colleges.
- . Last date of submissions for STPM students is Saturday, 17th August 2024

SGI Scholarship Details



1. ***RM 10,000 per year***
2. ***Total scholarship range from RM 20,000 to RM 40,000 depending on length of course (2 years, 3 years to max 4 years)***
3. ***At least two scholarships per year will be awarded where possible depending on the funds available***
4. ***Applicable for both academic (first degree) and vocational courses***
5. ***Tuition fees and any surplus will be paid direct to applicants as living expenses***
6. ***Subsequent payment is conditional upon student passing semester examinations***

Who can apply ?

- 1. *Must be Malaysian Citizen***
- 2. *Age between 17 and 21 at time of application***
- 3. *Offered a place at a recognized university or college***
- 4. *Taking a recognized academic or vocational course***
- 5. *Not holding other Scholarship Awards***
- 6. *Household Income not exceeding RM40,000 a year***
- 7. *For 2024 intake into University/Vocational College only***

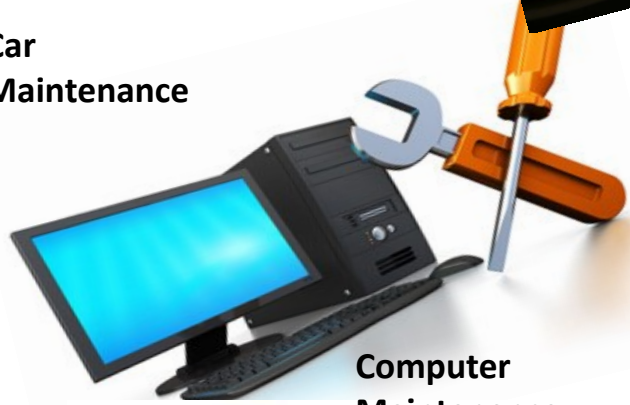

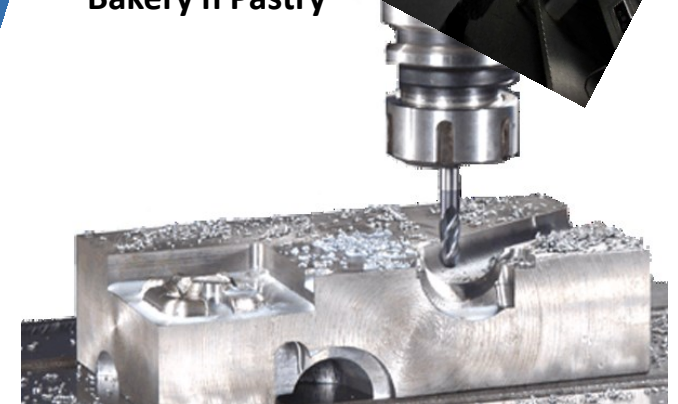

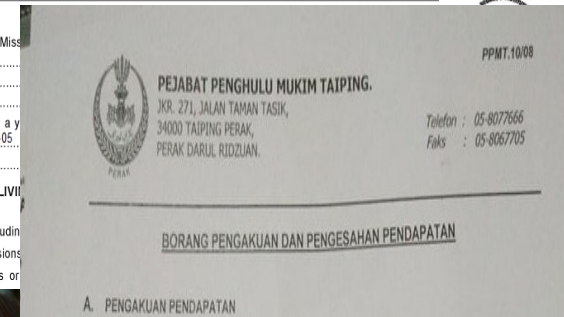

Selection Process ?



- . Step 1 – Short-listing, based on info on Application Form
(only shortlisted candidates will be called for interview)***
- . Step 2 – Personal Interview with Selection Panel
(interview will be conducted done at SMK St. George, Taiping
or online via Zoom Application)***
- . Step 3 – Provisional offer to successful candidate pending acceptance
letter from University or Vocational School***

Notification to Candidates



1. Candidates will be advised by WhatsApp or email the result of their interview as to whether they have been provisionally granted the scholarship or not.
2. The Scholarship will only be disbursed when proof of Acceptance by University/College or Vocational School is provided and also upon signing of the Scholarship Agreement.

Application Process

- July 2024 – Expected results of STPM
- 1 August 2024 – SGI Scholarship open for applications
- 17 August 2024 – Application submission close
- Mid August 2024 – Interview of short-listed candidates
- Early September 2024 – Successful candidates notified of Provisional Acceptance
- Mid September 2024 – Signing of Agreement and disbursement of fund
